# Nordhaus-Gaddum type results for the Harary index of graphs

> ABSTRACT
> The Harary index $H(G)$ of a connected graph $G$ is defined as $H(G)=\sum_{u, v \in V(G)} \frac{1}{d_{G}(u, v)}$, where $d_{G}(u, v)$ is the distance between vertices $u$ and $v$ of $G$. The Steiner distance in agraph, introduced by Chartrand et al. in 1989, is a natural generalization of the concept of classical graph distance. For a connected graph $G$ of order at least 2 and $S \subseteq V(G)$, the Steiner distance $d_{G}(S)$ of the vertices of $S$ is the minimum size of a connected subgraph whose vertex set contains $S$. Recently, Furtula, Gutman, and Katanić introduced the concept of Steiner Harary index and gave its chemical applications. The kcenter Steiner Harary index $S H_{k}(G)$ of $G$ is defined by $S H_{k}(G)=$ $\sum_{S \subseteq V(G),|S|=k} \frac{1}{d_{G}(S)}$. In this paper, we get the sharp upper and lower bounds for $S H_{k}(G)+S H_{k}(\bar{G})$ and $S H_{k}(G) \cdot S H_{k}(\bar{G})$, valid for any connected graph $G$ whose complement $\bar{G}$ is also connected.

## 1. Introduction

All graphs in this paper are assumed to be undirected, finite and simple and connected. We refer to [5] for graph theoretical notation and terminology not specified here. For a graph $G$, let $V(G), E(G)$ and $e(G)=|E(G)|$ denote the set of vertices, the set of edges and the sizeof $G$, respectively.

[^0]If $S$ is a vertex-subset of a graph $G$, the subgraph of $G$ induced by $S$ is denoted by $G[S]$. We denote by $E_{G}[X, Y]$ the set of edges of $G$ with one end in $X$ and the other in $Y$. If $X=\{x\}$, we simply write $E_{G}[x, Y]$ for $E_{G}[\{x\}, Y]$.

The connectivity of a graph $G$, written $\kappa(G)$, is the order of a minimum vertexsubset $S \subseteq V(G)$ such that $G-S$ is disconnected or has only one vertex. Thus, if $G$ is connected, then $\kappa(G) \geq 1$; if $G$ has cut vertices, then $\kappa(G)=1$.

The introduction is divided into the three subsections, in order to state the motivations and results of this paper.

### 1.1 Distance and its Generalization

Distance is one of the basic concepts of graph theory [6]. If $G$ is a connected graph and $u, v \in V(G)$, then the distance $d(u, v)$ between $u$ and $v$ is the length of a shortest path connecting $u$ and $v$.

The distance between two vertices $u$ and $v$ in a connected graph $G$ also equals the minimum size of a connected subgraph of $G$ containing both $u$ and $v$. This observation suggests a generalization of the distance concept. The Steiner distance of a graph, introduced by Chartrand et al. in 1989 [8], is a natural generalization of the classical graph distance. For a graph $G(V, E)$ and a set $S \subseteq V(G)$ of at least two vertices, an S-Steiner tree or a Steiner tree connecting $S$ (or simply, an S-tree) is a subgraph $T\left(V^{\prime}, \mathrm{E}^{\prime}\right)$ of $G$ that is a tree with $S \subseteq V^{\prime}$. Then the Steiner distance $d_{G}(S)$ of the vertices of $S$ (or simply the distance of $S$ ) is the minimum size of all connected subgraphs whose vertex sets contain $S$. Observe that $d_{G}(S)=\min \{e(T) \mid S \subseteq V(T)\}$, where $T$ is subtree of $G$. Furthermore, if $S=\{u, v\}$, then $d_{G}(S)$ coincides with the classical distance between $u$ and $v$.

Observation 1.1 Let $G$ be a connected graph of order $n$ and $k$ be an integer, $2 \leq k \leq n$. If $S \subseteq V(G)$ and $|S|=k$, then $k-1 \leq d_{G}(S) \leq n-1$.

The average Steiner distance $\mu_{k}(G)$ of a graph $G$, introduced by Dankelmann et al. [9, 10 ], is defined as the average of the Steiner distances of all k -subsets of $V(G)$, i.e.,

$$
\begin{equation*}
\mu_{k}(G)=\binom{n}{k}^{-1} \sum_{\substack{S \subseteq V(G) \\|S|=k}} d_{G}(S) . \tag{1.1}
\end{equation*}
$$

Let $n$ and $k$ be integers such that $2 \leq k \leq n$. The Steiner k-eccentricity $e_{k}(v)$ of a vertex $v$ of $G$ is defined by $e_{k}(v)=\max \{d(S)|S \subseteq V(G),|S|=k, v \in S\}$. The Steiner kradius of $G$ is $\operatorname{srad}_{k}(G)=\min \left\{e_{k}(v) \mid v \in V(G)\right\}$, whereas the Steiner k-diameter of $G$ is $\operatorname{sdiam}_{k}(G)=\max \left\{e_{k}(v) \mid v \in V(G)\right\}$. Note that for any vertex $v$ of any connected graph
$G, e_{2}(v)=e(v)$, and in addition $\operatorname{srad}_{2}(G)=\operatorname{rad}(G)$ and $\operatorname{sdiam}_{2}(G)=\operatorname{diam}(G)$. For more details on Steiner distance, we refer to [3, 7, 8, 9, 10, 17, 25, 29].

Mao [25] obtained the following results. By $\Delta(G)$ we denote the greatest degree of a vertex of $G$.

Lemma 1.1 [25] Let $G$ be a connected graph with connected complement $\bar{G}$. If $\operatorname{sdiam}_{k}(G) \geq 2 k$, then $\operatorname{sdiam}_{k}(\bar{G}) \leq k$.

Lemma 1.2 [25] Let $G$ be a connected graph of order $n$. Then $\operatorname{sdiam}_{3}(G)=2$ if and only if $0 \leq \Delta(\bar{G}) \leq 1$.

Lemma 1.3 [25] Let $n, k$ be integers such that $2 \leq k \leq n$, and let $G$ be a connected graph of order $n$. If $\operatorname{sdiam}_{k}(G)=k-1$, then $0 \leq \Delta(\bar{G}) \leq k-2$.

Lemma 1.4 [25] Let $G$ be a connected graph of order $n$ with connected complement. Let $k$ be an integer such that $3 \leq k \leq n$. Let $x=0$ if $n \geq 2 k-2$ and $x=1$ if $n<2 k-2$. Then
(1) $2 k-1-x \leq \operatorname{siam}_{k}(G)+\operatorname{siam}_{k}(\bar{G}) \leq \max \{n+k-1,4 k-2\}$;
(2) $(k-1)(k-x) \leq \operatorname{sdiam}_{k}(G) \cdot \operatorname{sdiam}_{k}(\bar{G}) \leq \max \left\{k(n-1),(2 k-1)^{2}\right\}$.

Lemma 1.5 [25] Let $G$ be a graph. Then $\operatorname{sdiam}_{n-1}(G)=n-2$ if and only if $G$ is 2connected.

The following corollary is immediate from the above lemmas.
Corollary 1.1 [28] Let $G$ and $\bar{G}$ be connected graphs. If $\operatorname{sdiam}_{3}(G) \geq 6$, then $\operatorname{sdiam}_{3}(\bar{G})=3$.

### 1.2 Wiener Index and its Generalization

The Wiener index is defined as the sum of ordinary distances of all pairs of vertices of the underlying graph, i.e., as $W(G)=\sum_{u, v \in V(G)} d(u, v)$ and its mathematical theory is nowadays well elaborated. For details see the surveys [13, 34].

Li et al. [22] generalized the concept of Wiener index using Steiner distance, by defining the Steiner k-Wiener index $S W_{k}(G)$ of the connected graph $G$ as

$$
S W_{k}(G)=\sum_{\substack{S \subseteq V(G) \\|S|=k}} d_{G}(S) .
$$

However, with regard to this definition, one should bear in mind Eq. (1.1), and the references [9, 10].

For $k=2$, the Steiner Wiener index coincides with the ordinary Wiener index. It is usual to consider $S W_{k}$ for $2 \leq k \leq n-1$, but the above definition implies $S W_{1}(G)=$ 0 and $S W_{n}(G)=n-1$.

An application in chemistry of the Steiner Wiener index was reported in [18]. Expressions for $S W_{k}$ for some special graphs were reported in [22]. Li et al. [22] also gave sharp upper and lower bounds on $S W_{k}$, and established some of its properties in the case of trees. For more details on the Steiner Wiener index, we refer to [18, 22, 23, 27].

### 1.3 HARARY Index and its Generalization

The Harary index $H(G)$ of $G$ is defined by $H(G)=\sum_{u, v \in V(G)} \frac{1}{d_{G}(u, v)}$. For more details on the Harary index, we refer to $[4,21,24,33]$.

Furtula et al. [15] introduced the concept of Steiner Harary index. The Steiner Harary $k$-index or $k$-center Steiner Harary index $S H_{k}(G)$ of $G$ is defined as

$$
S H_{k}(G)=\sum_{\substack{S \subseteq V(G) \\|S|=k}} \frac{1}{d_{G}(S)} .
$$

For $k=2$, the above defined Steiner Harary index coincides with the ordinary Harary index. It is usual to consider $S H_{k}$ for $2 \leq k \leq n-1$, but the above definition implies $S H_{1}(G)=0$ and $S H_{n}(G)=\frac{1}{n-1}$.

The following results will be needed later.
Lemma 1.6 [26] Let $T$ be a tree of order $n$, and let $k$ be an integer such that $2 \leq k \leq n$. Then

$$
n \sum_{k-1 \leq t \leq n-1} \frac{1}{t}\binom{t-1}{k-2}-\binom{n-1}{k-1} \leq S H_{k}(T) \leq \frac{k n-n+k}{k^{2}(k-1)}\binom{n-1}{k-1}
$$

Moreover, among all trees of order $n$, the star $S_{n}$ maximizes the Steiner Harary k-index whereas the path $P_{n}$ minimizes the Steiner Harary k-index.

Lemma 1.7 [26] Let $P_{n}$ be the path of order $n(n \geq 3)$, and let $k$ be an integer such that $2 \leq k \leq n$. Then

$$
S H_{k}\left(P_{n}\right)=n \quad \sum_{k-1 \leq t \leq n-1} \frac{1}{t}\binom{t-1}{k-2}-\binom{n-1}{k-1} .
$$

## 2. Main Results

Let $f(G)$ be a graph invariant and na positive integer, $n \geq 2$. The Nordhaus-Gaddum Problem is to determine sharp bounds for $f(G)+f(\bar{G})$ and $f(G) \cdot f(\bar{G})$, as $G$ ranges over the class of all graphs of order $n$, and to characterize the extremal graphs, i.e., graphs that achieve the bounds. Nordhaus-Gaddum type relations have received wide attention; see the recent survey [2] by Aouchiche and Hansen.

Denote by $\mathcal{G}(n)$ the class of connected graphs of order $n$ whose complements are also connected. In the studies of Nordhaus-Gaddum-type relations it must be assumed that $f(G)$ and $f(\bar{G})$ exist. Therefore, such relations are examined in the case of Wiener and Steiner Wiener indices, one must restrict the consideration to the class $\mathcal{G}(n), n \geq 2$.

Mao et al. [28] studied the Nordhaus-Gaddum type results for the Wiener index. In this paper, we investigate the analogous problem for the Steiner Harary index. Our basic idea is from [28].

### 2.1 Results Pertaining to General k

For general $k$, we obtain the following result:
Theorem 2.1 Let $G \in \mathcal{G}(n)$ and let $k$ be an integer such that $3 \leq k \leq n$. Then:
(1) $\binom{n}{k} \frac{2 k-2}{\max \left\{k(n-1),(2 k-1)^{2}\right\}} \leq S H_{k}(G)+S H_{k}(\bar{G}) \leq \frac{(n+k-2)\binom{n}{k}}{(k-1)^{2}}$.
(2) $\frac{1}{\max \left\{k(n-1),(2 k-1)^{2}\right\}}\binom{n}{k}^{2} \leq S H_{k}(G) \cdot S H_{k}(\bar{G}) \leq \frac{1}{(k-1)^{2}}\binom{n}{k}^{2}$.

Moreover, the lower bounds are sharp.
Proof. Proof of part (1):
For any $S \subseteq V(G)$ and $|S|=k$, from the definition of Steiner diameter, we have $d_{G}(S)+$ $d_{\bar{G}}(S) \leq \max \{n+k-2,2 k-2\}=n+k-2$. Then

$$
\begin{aligned}
& S H_{k}(G)+S H_{k}(\bar{G})=\sum_{S \subseteq V(G)} \frac{1}{d_{G}(S)}+\sum_{S \subseteq V(\bar{G})} \frac{1}{d_{\bar{G}}(S)}=\sum_{S \subseteq V(G)} \frac{d_{G}(S)+d_{\bar{G}}(S)}{d_{G}(S) d_{\bar{G}}(S)} \\
& \leq \frac{(n+k-2)\binom{n}{k}}{(k-1)^{2}}
\end{aligned}
$$

By the same reason, Lemma 1.4 implies

$$
S H_{k}(G)+S H_{k}(\bar{G})=\sum_{S \subseteq V(G)} \frac{d_{G}(S)+d_{\bar{G}}(S)}{d_{G}(S) d_{\bar{G}}(S)} \geq\binom{ n}{k} \frac{2 k-2}{\max \left\{k(n-1),(2 k-1)^{2}\right\}}
$$

Proof of part (2):
For any $S^{\prime} \subseteq V(G),\left|S^{\prime}\right|=k$ and any $S^{\prime \prime} \subseteq V(\bar{G}),\left|S^{\prime \prime}\right|=k$, from the definition of Steiner diameter and Lemma 1.4, we have $d_{G}\left(S^{\prime}\right) \cdot d_{\bar{G}}\left(S^{\prime \prime}\right) \leq \max \left\{k(n-1),(2 k-1)^{2}\right\}$. Then

$$
\begin{gathered}
S H_{k}(G) \cdot S H_{k}(\bar{G})=\sum_{S^{\prime} \subseteq V(G)} \frac{1}{d_{G}\left(S^{\prime}\right)} \cdot \sum_{S^{\prime \prime} \subseteq V(\bar{G})} \frac{1}{d_{\bar{G}}\left(S^{\prime \prime}\right)}=\sum_{S^{\prime} \subseteq V(G), S^{\prime \prime} \subseteq V(\bar{G})} \frac{1}{d_{G}\left(S^{\prime}\right)} \cdot \frac{1}{d_{\bar{G}}\left(S^{\prime \prime}\right)} \\
\geq \frac{1}{\max \left\{k(n-1),(2 k-1)^{2}\right\}}\binom{n}{k}^{2}
\end{gathered}
$$

For any $S^{\prime} \subseteq V(G),\left|S^{\prime}\right|=k$ and any $S^{\prime \prime} \subseteq V(\bar{G}),\left|S^{\prime \prime}\right|=k$, from the definition of Steiner diameter and Lemma 1.4, we have $d_{G}\left(S^{\prime}\right) \cdot d_{\bar{G}}\left(S^{\prime \prime}\right) \geq(k-1)^{2}$. Then

$$
\begin{aligned}
& S H_{k}(G) \cdot S H_{k}(\bar{G})=\sum_{S^{\prime} \subseteq V(G)} \frac{1}{d_{G}\left(S^{\prime}\right)} \cdot \sum_{S^{\prime \prime} \subseteq V(\bar{G})} \frac{1}{d_{\bar{G}}\left(S^{\prime \prime}\right)}=\sum_{S^{\prime} \subseteq V(G), S^{\prime \prime} \subseteq V(\bar{G})} \frac{1}{d_{G}\left(S^{\prime}\right)} \cdot \frac{1}{d_{\bar{G}}\left(S^{\prime \prime}\right)} \\
& \leq \frac{1}{(k-1)^{2}}\binom{n}{k}^{2}
\end{aligned}
$$

as desired.

## 3. FOR SOME $k$

For $k=n, n-1,3$, we can improve the results in Theorem 2.1.

### 3.1 The Case $k=n, n-1$

For $k=n$, the following result is immediate.
Observation 3.1 Let $G \in \mathcal{G}(n)$. Then
(1) $S H_{n}(G)+S H_{n}(\bar{G})=\frac{2}{n-1}$;
(2) $S H_{n}(G) \cdot S H_{n}(\bar{G})=\frac{1}{(n-1)^{2}}$.

Akiyama and Harary [1] characterized the graphs for which both $G$ and $\bar{G}$ are connected.

Lemma 3.1 [1] Let $G$ be graph with $n$ vertices and maximal vertex degree $\Delta(G)$. Then $\kappa(G)=\kappa(\bar{G})=1$ if and only if $G$ satisfies the following conditions.
i. $\quad \kappa(G)=1$ and $\Delta(G)=n-2$;
ii. $\quad \kappa(G)=1, \Delta(G) \leq n-3$, and $G$ has a cut vertex $v$ with pendent edge $u v$, such that $G-u$ contains a spanning complete bipartite subgraph.

For $k=n-1$, we have the following result:

Proposition 3.1 Let $G$ be a graph of order $n(n \geq 5)$.

1. If $G$ and $\bar{G}$ are both 2 -connected, then $S H_{n-1}(G)+S H_{n-1}(\bar{G})=\frac{2 n}{n-2}$ and $S H_{n-1}(G) \cdot S H_{n-1}(\bar{G})=\frac{n^{2}}{(n-2)^{2}}$.
2. If $\kappa(G)=1$ and $\bar{G}$ is 2 -connected, then $S H_{n-1}(G)+S H_{n-1}(\bar{G})=\frac{p}{n-1}+\frac{2 n-p}{n-2}$ and $S H_{n-1}(G) \cdot S H_{n-1}(\bar{G})=\frac{p n}{(n-1)(n-2)}+\frac{n(n-p)}{(n-2)^{2}}$, where $p$ is the number of cut vertices in $G$.
3. If $\kappa(G)=\kappa(\bar{G})=1, \Delta(G) \leq n-3$, and $G$ has a cut vertex $v$ with pendent edge $u v$ such that $G-u$ contains a spanning complete bipartite subgraph, and $\Delta(\bar{G}) \leq n-3$ and $\bar{G}$ has a cut vertex $q$ with pendent edge $p q$ such that $G-p$ contains a spanning complete bipartite subgraph, then $S H_{n-1}(G)+$ $S H_{n-1}(\bar{G})=\frac{2 n^{2}-2 n-2}{(n-1)(n-2)}$ and $S H_{n-1}(G) \cdot S H_{n-1}(\bar{G})=\frac{\left(n^{2}-n-1\right)^{2}}{(n-1)^{2}(n-2)^{2}}$.
4. If $\kappa(G)=\kappa(\bar{G})=1, \Delta(\bar{G})=n-2, \Delta(G) \leq n-3$ and $G$ has a cut vertex $v$ with pendent edge $u v$ such that $G-u$ contains a spanning complete bipartite subgraph, then $S H_{n-1}(G)+S H_{n-1}(\bar{G})=\frac{2 n^{2}-2 n-2}{(n-1)(n-2)} \quad$ or $\quad S H_{n-1}(G)+$

$$
\begin{aligned}
& S H_{n-1}(\bar{G})=\frac{2 n^{2}-2 n-3}{(n-1)(n-2)} \quad \text { and } \quad S H_{n-1}(G) \cdot S H_{n-1}(\bar{G})=\frac{\left(n^{2}-n-1\right)^{2}}{(n-1)^{2}(n-2)^{2}} \quad \text { or } \\
& S H_{n-1}(G) \cdot S H_{n-1}(\bar{G})=\frac{\left(n^{2}-n-1\right)(n+1)}{(n-1)^{2}(n-2)}
\end{aligned}
$$

5. If $\kappa(G)=\kappa(\bar{G})=1, \Delta(G)=\Delta(\bar{G})=n-2$, then $\frac{2(n+1)}{n-1} \leq S H_{n-1}(G)+$ $S H_{n-1}(\bar{G}) \leq \frac{2 n^{2}-2 n-2}{(n-1)(n-2)}$ and $\frac{(n+1)^{2}}{(n-1)^{2}} \leq S H_{n-1}(G) \cdot S H_{n-1}(\bar{G}) \leq \frac{\left(n^{2}-n-1\right)^{2}}{(n-1)^{2}(n-2)^{2}}$.

Proof. (1): From Lemma 1.5, if $G$ and $\bar{G}$ are both connected, then $d_{G}(S)=n-2$ and $d_{\bar{G}}(S)=n-2$ for any $S \subseteq V(G)$ and $|S|=n-1$. Therefore, $S H_{n-1}(G)+S H_{n-1} \bar{G}=$ $\frac{2 n}{n-2}$ and $S H_{n-1}(G) \cdot S H_{n-1}(\bar{G})=\frac{n^{2}}{(n-2)^{2}}$.
(2): Since $\bar{G}$ is 2-connected, it follows that $d_{\bar{G}}(S)=n-2$ for any $S \subseteq V(G)$ and $|S|=$ $n-1$, and hence $S H_{n-1}(\bar{G})=\frac{n}{n-2}$. Note that $\kappa(G)=1$ and there are exactly $p$ cut vertices in $G$. For any $S \subseteq V(G)$ and $|S|=n-1$, if the unique vertex in $V(G) \backslash S$ is a cut vertex, then $d_{G}(S)=n-1$. If the unique vertex in $V(G) \backslash S$ is not a cut vertex, then $d_{G}(S)=n-2$. Therefore, we have $S H_{n-1}(G)=\frac{p}{n-1}+\frac{n-p}{n-2}$, and hence $S H_{n-1}(G)+$ $S H_{n-1}(\bar{G})=\frac{p}{n-1}+\frac{2 n-p}{n-2}$ and $S H_{n-1}(G) \cdot S H_{n-1}(\bar{G})=\frac{p n}{(n-1)(n-2)}+\frac{n(n-p)}{(n-2)^{2}}$, where $p$ is the number of cut vertices in $G$.
(3), (4), (5): We have $\kappa(G)=\kappa(\bar{G})=1$. By condition ( $i$ ) of Lemma 3.1, since $\Delta(G)=$ $n-2$, there is a vertex of degree $n-2$, say $x$. Let the set of first neighbors of $x$ be $N_{G}(x)=\left\{y_{1}, y_{2}, \cdots, y_{n-2}\right\}$. Let $V(G) \backslash\left(\{x\} \cup N_{G}(x)\right)=\{z\}$. Since $z x \notin E(G)$, there must exist a vertex in $N_{G}(x)$, say $y_{1}$, such that $z y_{1} \in E(G)$, since $G$ is connected. Since $x, y_{1}$ may be the cut vertices in $G$, it follows that there are one or two cut vertices in $G$. So

$$
S H_{n-1}(G)=\frac{1}{n-1}+\frac{n-1}{n-2}=\frac{n^{2}-n-1}{(n-1)(n-2)} \text { or } S H_{n-1}(G)=\frac{2}{n-1}+\frac{n-2}{n-2}=\frac{n+1}{n-1} .
$$

By condition (ii) of Lemma 3.1, since $\Delta(G) \leq n-3$ and $G$ has a cut vertex $v$ with pendent edge $u v$ such that $G-u$ contains a spanning complete bipartite subgraph, it follows that $v$ is the unique cut vertex. So $S H_{n-1}(G)=\frac{1}{n-1}+\frac{n-1}{n-2}=\frac{n^{2}-n-1}{(n-1)(n-2)}$. From this argument, (3), (4), (5) are true.

### 3.2 The Case k = 3

The following lemmas and corollaries will be used later.

Lemma 3.2 [28] Let $T$ be a tree of order $n$, and let $k$ be an integer such that $3 \leq k \leq n$. Then there exist at least $(n-k+1)$ subsets of $V(T)$ for which the Steiner k-distance is equal to $k-1$.

Corollary 3.1 [28] Let $G$ be a connected graph of order $n$, and let $k$ be an integer such that $3 \leq k \leq n$. Then there exist at least $(n-k+1)$ subsets of $V(G)$ whose Steiner k-distance is $k-1$.

Lemma 3.3 [28] Let $T$ be a tree of order $n$, and let $k$ be an integer such that $3 \leq k \leq n-$ 1 . Then there exist at least $(n-k)$ subsets of $V(T)$ whose Steiner k-distance is $k$.

In this section, we focus our attention on the case $k=3$. For $k=3$ and $n \geq 10$, from Theorem 2.1, we have $\binom{n}{3} \frac{4}{3(n-1)} \leq S H_{3}(G)+S H_{3}(\bar{G}) \leq \frac{(n+1)\binom{n}{3}}{4}$ and $\frac{1}{3(n-1)}\binom{n}{3}^{2} \leq$ $S H_{3}(G) \cdot S H_{3}(\bar{G}) \leq \frac{1}{4}\binom{n}{3}^{2}$.

We improve these bounds and prove the following result.
Theorem 3.1 Let $G \in \mathcal{G}(n)$ with $n \geq 4$. Then

1. $\frac{5}{6}\binom{n}{3} \geq S H_{3}(G)+S H_{3}(\bar{G}) \geq$
$\left\{\begin{array}{c}\frac{7}{10}\binom{n}{3}+\frac{11}{60} n-\frac{1}{2} \quad \text { if } n=6,7 \text { and } \operatorname{sdiam}_{3}(G)=5 \\ \quad \text { or } n=6,7 \text { and } \operatorname{sdiam}_{3}(\bar{G})=5 \\ \frac{1}{2}\binom{n-3}{3}-\sum_{i=2}^{n-1} \frac{n}{i}+\frac{7 n^{2}-23 n+20}{6} \quad \text { otherwise. }\end{array}\right.$
2. $\frac{25}{144}\left[\binom{n}{3}^{2}\right] \geq S H_{3}(G) \cdot S H_{3}(\bar{G}) \geq\left[\frac{1}{n-1}\binom{n}{3}+\frac{(n-3)(n-2)}{2(n-1)}\right]\left[\frac{1}{2}\binom{n}{3}-\frac{(n-3)(n-2)}{2(n-1)}\right]$.

Moreover, the bounds are sharp.

We first need the following lemma.
Lemma 3.4 [28] Let $G$ be a connected graph. If $\operatorname{sdiam}_{3}(G)=5$, then $\operatorname{sdiam}_{3}(\bar{G}) \leq 4$.

Lemma 3.5 Let $G \in \mathcal{G}(n)$. Then

$$
\begin{align*}
& \mathrm{SH}_{3}(G)+\mathrm{SH}_{3}(\bar{G}) \leq \frac{5}{6}\binom{n}{3}  \tag{3.1}\\
& \mathrm{SH}_{3}(G) \cdot \mathrm{SH}_{3}(\bar{G}) \leq \frac{25}{144}\binom{n}{3}^{2} \tag{3.2}
\end{align*}
$$

and

$$
\begin{equation*}
S H_{3}(G) \cdot S H_{3}(\bar{G}) \geq\left[\frac{1}{n-1}\binom{n}{3}+\frac{(n-3)(n-2)}{2(n-1)}\right]\left[\frac{1}{2}\binom{n}{3}-\frac{(n-3)(n-2)}{2(n-1)}\right] . \tag{3.3}
\end{equation*}
$$

Moreover, the bounds are sharp.
Proof. (1) For any $S \subseteq V(G)$ and $|S|=3, G[S] \cong K_{3}$ or $G[S] \cong P_{3}$ or $G[S] \cong K_{2} \cup K_{1}$ or $G[S] \cong 3 K_{1}$. If $G[S] \cong K_{3}$ or $G[S] \cong P_{3}$, then $d_{G}(S)=2$. If $G[S] \cong K_{2} \cup K_{1}$ or $G[S] \cong$ $3 K_{1}$, then $d_{G}(S) \geq 3$. Let $S_{1}, S_{2}, \cdots, S_{\binom{n}{3}}$ be all the 3 -subsets of $V(G)$. Without loss of generality, let $S_{1}, S_{2}, \cdots, S_{x}$ be all the 3 -subsets of $V(G)$ such that $G\left[S_{i}\right] \cong K_{3}$ or $G\left[S_{i}\right] \cong P_{3}$, where $1 \leq i \leq x$. Therefore, $d_{G}\left(S_{i}\right)=2$ and $d_{\bar{G}}\left(S_{i}\right) \geq 3$ for each $i(1 \leq i \leq x)$. Furthermore, for any $S_{j}\left(x+1 \leq j \leq\binom{ n}{3}\right)$, we have

$$
\begin{aligned}
& \mathrm{SH}_{3}(G) \leq \frac{x}{2}+\frac{\left[\binom{n}{3}-x\right]}{3}=\frac{1}{3}\binom{n}{3}+\frac{x}{6} \\
& \mathrm{SH}_{3}(\bar{G}) \leq \frac{x}{3}+\frac{\left[\binom{n}{3}-x\right]}{2}=\frac{1}{2}\binom{n}{3}-\frac{x}{6} \\
& \mathrm{SH}_{3}(G) \geq \frac{x}{2}+\frac{\left[\binom{n}{3}-x\right]}{n-1}=\frac{1}{n-1}\binom{n}{3}+\frac{(n-3) x}{2(n-1)} .
\end{aligned}
$$

and

$$
\mathrm{SH}_{3}(\bar{G}) \geq \frac{x}{n-1}+\frac{\left[\binom{n}{3}-x\right]}{2}=\frac{1}{2}\binom{n}{3}-\frac{(n-3) x}{2(n-1)} .
$$

implying inequality (3.1).
By Corollary 3.1, there exist at least $n-2$ subsets of $V(G)$ whose Steiner 3-distances are equal to 2 . The same is true for $\bar{G}$. Therefore, $n-2 \leq x \leq\binom{ n}{3}-n+2$, and hence

$$
\begin{aligned}
\mathrm{SH}_{3}(G) \cdot \mathrm{SH}_{3}(\bar{G}) & \leq\left[\frac{1}{3}\binom{n}{3}+\frac{x}{6}\right]\left[\frac{1}{2}\binom{n}{3}-\frac{x}{6}\right] \\
& =\frac{1}{6}\binom{n}{3}^{2}+\frac{x}{36}\binom{n}{3}-\frac{x^{2}}{36} \\
& \leq \frac{1}{36}\left[6\binom{n}{3}^{2}+\frac{1}{4}\binom{n}{3}^{2}\right] \\
& =\frac{25}{144}\left[\binom{n}{3}^{2}\right]
\end{aligned}
$$

i.e., inequality (3.2) holds.

$$
\begin{aligned}
\mathrm{SH}_{3}(G) \cdot \mathrm{SH}_{3} & (\bar{G}) \\
& \geq\left[\frac{1}{n-1}\binom{n}{3}+\frac{(n-3) x}{2(n-1)}\right]\left[\frac{1}{2}\binom{n}{3}-\frac{(n-3) x}{2(n-1)}\right] \\
& =\frac{1}{2(n-1)}\binom{n}{3}^{2}+\frac{(n-3)^{2} x}{4(n-1)^{2}}\binom{n}{3}-\frac{(n-3)^{2} x^{2}}{4(n-1)^{2}} \\
& \geq\left[\frac{1}{n-1}\binom{n}{3}+\frac{(n-3)(n-2)}{2(n-1)}\right]\left[\frac{1}{2}\binom{n}{3}-\frac{(n-3)(n-2)}{2(n-1)}\right]
\end{aligned}
$$

i.e., inequality (3.3) holds.

The sharpness of the above bounds is illustrated by the following example.

Example 3.2 Let $G \cong P_{4}$. Then $\bar{G} \cong P_{4}$. By Lemma 1.7, $S H_{3}(G)=S H_{3}(\bar{G})=\frac{5}{3}$, and hence $\mathrm{SH}_{3}(G)+\mathrm{SH}_{3}(\bar{G})=\frac{10}{3}=\frac{5}{6}\binom{n}{3} \quad$ and $\quad \mathrm{SH}_{3}(G) \cdot \mathrm{SH}_{3}(\bar{G})=\frac{25}{9}=\frac{25}{144}\left[\binom{n}{3}^{2}\right]=$ $\left[\frac{1}{n-1}\binom{n}{3}+\frac{(n-3)(n-2)}{2(n-1)}\right]\left[\frac{1}{2}\binom{n}{3}-\frac{(n-3)(n-2)}{2(n-1)}\right]$, which confirms that the lower and upper bounds are sharp.

Let $S^{*}$ be a tree obtained from a star of order $n-2$ and a path of length 2 by identifying the center of the star and a vertex of degree one in the path. Then $\overline{S^{*}}$ is a graph obtained from a clique of order $n-1$ by deleting an edge $u v$ and then adding an pendent edge at $v$.

## Observation 3.2

(1) $S H_{3}\left(S^{*}\right)=\frac{13}{12}\binom{n-3}{2}+\frac{1}{3}\binom{n-3}{3}+\frac{7}{6} n-3$;
(2) $\mathrm{SH}_{3}\left(\overline{S^{*}}\right)=\frac{4}{3}\binom{n-3}{2}+\frac{1}{2}\binom{n-3}{3}+\frac{4}{3} n-\frac{11}{3}$.

Proof. From the structure of $S^{*}$ and $\overline{S^{*}}$, we conclude

$$
\begin{aligned}
\mathrm{SH}_{3}\left(S^{*}\right) & =\frac{1}{4}\binom{n-3}{2}+\frac{1}{2}\left[\binom{n-3}{2}+(n-3)+1\right] \\
& +\frac{1}{3}\left[\binom{n-3}{2}+\binom{n-3}{3}+2(n-3)\right] \\
& =\frac{13}{12}\binom{n-3}{2}+\frac{1}{3}\binom{n-3}{3}+\frac{7}{6} n-3
\end{aligned}
$$

and

$$
\begin{aligned}
\mathrm{SH}_{3}\left(\overline{S^{*}}\right) & =\frac{1}{2}\left[2\binom{n-3}{2}+2(n-3)+\binom{n-3}{3}\right]+\frac{1}{3}\left[\binom{n-3}{2}+(n-2)\right] \\
& =\frac{4}{3}\binom{n-3}{2}+\frac{1}{2}\binom{n-3}{3}+\frac{4}{3} n-\frac{11}{3} .
\end{aligned}
$$

In order to show the sharpness of the above bounds, we consider the following example.

Example 3.3 Let $S^{*}$ be the same tree as before. From Observation 3.2, we have

$$
\mathrm{SH}_{3}\left(S^{*}\right)+\mathrm{SH}_{3}\left(\overline{S^{*}}\right)=\frac{29}{12}\binom{n-3}{2}+\frac{5}{6}\binom{n-3}{3}+\frac{15}{6} n-\frac{20}{3}
$$

and

$$
\begin{aligned}
\mathrm{SH}_{3}\left(S^{*}\right) \cdot \mathrm{S} H_{3}\left(\overline{S^{*}}\right)= & \frac{52}{36}\binom{n-3}{2}^{2}+\frac{1}{6}\binom{n-3}{3}^{2}+\frac{71}{72}\binom{n-3}{2}\binom{n-3}{3} \\
& +\left(\frac{27}{9} n-\frac{287}{36}\right)\binom{n-3}{2}+\left(\frac{37}{36} n-\frac{49}{18}\right)\binom{n-3}{3} \\
& +\left(\frac{4}{3} n-\frac{11}{3}\right)\left(\frac{7}{6} n-3\right) .
\end{aligned}
$$

The following lemmas are preparations for deducing an upper bound on $\mathrm{SH}_{3}(G)+$ $\mathrm{SH}_{3}(\bar{G})$.

Lemma 3.6 Let $G$ be a connected graph of order $n$, and let $T$ be a spanning tree of $G$. If $\operatorname{sdiam}_{3}(\bar{G})=3$, then

$$
\mathrm{SH}_{3}(T)+\mathrm{SH}_{3}(\bar{T}) \leq \mathrm{SH}_{3}(G)+S H_{3}(\bar{G})
$$

Proof. Note that $\bar{G}$ is a spanning subgraph of $\bar{T}$. It suffices to prove that

$$
\mathrm{SH}_{3}(\bar{T})-S H_{3}(\bar{G}) \leq \mathrm{SH}_{3}(G)-S H_{3}(T)
$$

Since $\operatorname{sdia} m_{3}(\bar{G})=3$, it follows that $d_{\bar{G}}(S)=2$ or $d_{\bar{G}}(S)=3$ for any $S \subseteq V(G)$ and $|S|=3$. Since $\bar{G}$ is a spanning subgraph of $\bar{T}$ and $\operatorname{sdiam}_{3}(\bar{G})=3$, it follows that $\operatorname{sdiam}_{3}(\bar{T}) \leq 3$, and hence $d_{\bar{T}}(S)=2$ or $d_{\bar{T}}(S)=3$ for any $S \subseteq V(T)$ and $|S|=3$. Then $0 \leq \frac{1}{d_{\bar{T}}(S)}-\frac{1}{d_{\bar{G}}(S)} \leq \frac{1}{6}$. We claim that $\frac{1}{d_{\bar{T}}(S)}-\frac{1}{d_{\bar{G}}(S)} \leq \frac{1}{d_{G}(S)}-\frac{1}{d_{T}(S)}$ for $S \subseteq V(T)$ and
$|S|=3$. Because $\bar{G}$ is a spanning subgraph of $\bar{T}, \frac{1}{d_{\bar{G}}(S)} \leq \frac{1}{d_{\bar{T}}(S)}$ for any $S \subseteq V(T)$ and $|S|=3$. Similarly, since $T$ is a spanning subgraph of $G, \frac{1}{d_{T}(S)} \leq \frac{1}{d_{G}(S)}$ for any $S \subseteq V(T)$ and $|S|=3$. If $\frac{1}{d_{\bar{T}}(S)}-\frac{1}{d_{\bar{G}}(S)}=0$, then $\frac{1}{d_{\bar{T}}(S)}-\frac{1}{d_{\bar{G}}(S)}=0 \leq \frac{1}{d_{G}(S)}-\frac{1}{d_{T}(S)}$, as desired. If $\frac{1}{d_{\bar{T}}(S)}-$ $\frac{1}{d_{\bar{G}}(S)}=\frac{1}{6}$, then $d_{\bar{G}}(S)=3$ and $d_{\bar{T}}(S)=2$, and hence $d_{G}(S)=2$ and $d_{T}(S) \geq 3$. Therefore, $\frac{1}{d_{G}(S)}-\frac{1}{d_{T}(S)} \geq \frac{1}{6}=\frac{1}{d_{\bar{T}}(S)}-\frac{1}{d_{\bar{G}}(S)}$, as desired. The result follows from the arbitrariness of $S$ and the definition of Steiner Wiener index.

Lemma 3.7 Let $T$ be a tree of order $n$, different from the star $S_{n}$. Let $S^{*}$ be the tree same as in Observation 3.2. If $\operatorname{sdiam}_{3}(\bar{G})=3$, then

$$
\mathrm{SH}_{3}\left(P_{n}\right)+\mathrm{SH}_{3}\left(\overline{S^{*}}\right) \leq \mathrm{SH}_{3}(T)+S H_{3}(\bar{T})
$$

Proof. Note first that the complements of all trees, except of the star, are connected. Therefore, $\mathrm{SH}_{3}(\bar{T})$ in Lemma 3.7 is always well defined.

By Lemma 1.6 and 1.7, $\mathrm{SH}_{3}\left(P_{n}\right) \leq \mathrm{SH}_{3}(T)$. It suffices to prove $\mathrm{SH}_{3}\left(\overline{S^{*}}\right) \leq \mathrm{SH}_{3}(\bar{T})$. Since $\operatorname{sdiam}_{3}(\bar{G}) \leq 3$, it follows that $\operatorname{sdiam}_{3}(\bar{T}) \leq 3$. For any $S \subseteq V(T)$ and $|S|=3$, if $T[S]$ is not connected, then $d_{\bar{T}}(S)=2$. If $T[S]$ is connected, then $d_{\bar{T}}(S) \geq 3$. So if we want to obtain the minimum value of $\mathrm{SH}_{3}(\bar{T})$ for a tree $T$, then we need to find as less as possible 3-subsets of $V(T)$ whose induced subgraphs in $\bar{T}$ are disconnected. Since the complement of $S_{n}$ is not connected, it follows that $\overline{S^{*}}$ is our desired. So $\mathrm{SH}_{3}\left(\overline{S^{*}}\right) \leq$ $S H_{3}(\bar{T})$, and hence $S H_{3}\left(P_{n}\right)+S H_{3}\left(\overline{S^{*}}\right) \leq S H_{3}(T)+S H_{3}(\bar{T})$.

We are now in the position to complete the proof of Theorem 3.1. This will be achieved by combining Lemmas 3.5 and 3.8.

Let $G \in \mathcal{G}(n)$. If $n=6,7$ and $\operatorname{sdiam}_{3}(G)=5$, then the validity of Theorem 3.1 can be verified by direct checking.

Lemma 3.8 Let $G \in \mathcal{G}(n)$. Let $n \geq 8$, or $n \leq 5$, or $n=6,7$ and $\operatorname{sdiam}_{3}(G) \neq 5$, or $n=6,7$ and $\operatorname{sdiam}_{3}(\bar{G}) \neq 5$. Then the lower bounds in parts (1) and (2) of Theorem 3.1 are obeyed. Moreover, these bounds are sharp.

Proof. We need to separately examine three cases.

Case 1. $\operatorname{sdiam}_{3}(G) \geq 6$ or $\operatorname{sdiam}_{3}(\bar{G}) \geq 6$. Without loss of generality, let $\operatorname{sdiam}_{3}(G) \geq$ 6. From Corollary 1.1 it is known that $\operatorname{sdiam}_{3}(\bar{G})=3$, and hence $\mathrm{SH}_{3}(G)+\mathrm{SH}_{3}(\bar{G}) \geq$ $S H_{3}\left(P_{n}\right)+S H_{3}\left(\overline{S^{*}}\right)$. By Lemma 1.7, $S H_{3}\left(P_{n}\right)=\frac{(n+1)(n-2)}{2}-\sum_{i=2}^{n-1} \frac{n}{i}$. Note that $\overline{S^{*}}$ is a graph obtained from a clique of order $n-1$ by deleting an edge $u v$ and then adding a pendent edge at $v$. Then $\mathrm{SH}_{3}\left(\overline{S^{*}}\right)=\frac{4}{3}\binom{n-3}{2}+\frac{1}{2}\binom{n-3}{3}+\frac{4}{3} n-\frac{11}{3}$, and hence $\mathrm{SH}_{3}(G)+$ $S H_{3}(\bar{G}) \geq \frac{(n+1)(n-2)}{2}-\sum_{i=2}^{n-1} \frac{n}{i}+\frac{4}{3}\binom{n-3}{2}+\frac{1}{2}\binom{n-3}{3}+\frac{4}{3} n-\frac{11}{3}=\frac{1}{2}\binom{n-3}{3}-\sum_{i=2}^{n-1} \frac{n}{i}+$ $\frac{7 n^{2}-23 n+20}{6}$.

Case 2. $\operatorname{sdiam}_{3}(G)=5 \operatorname{orsdiam}{ }_{3}(\bar{G})=5$. In view of Lemma 3.4, we can assume that $\operatorname{sdiam}_{3}(G)=5$ and $\operatorname{sdiam}_{3}(\bar{G}) \leq 4$. Let $S_{1}, S_{2, \cdots,}, S_{\binom{n}{3}}$ be all the 3-subsets of $V(G)$. Without loss of generality, assume that $S_{1}, S_{2, \cdots,} S_{x}$ are the 3 -subsets of $V(G)$ for which $G\left[S_{i}\right] \cong K_{3}$ or $G\left[S_{i}\right] \cong P_{3}$, where $1 \leq i \leq x$.

For each $i(1 \leq i \leq x), d_{G}\left(S_{i}\right)=2$. For any $S_{j}\left(x+1 \leq j \leq\binom{ n}{3}\right), G\left[S_{j}\right] \cong K_{2} \cup K_{1}$ or $G\left[S_{j}\right] \cong 3 K_{1}$. Since $G$ is connected, it follows that there exists a spanning tree, say $T$. By Lemmas 3.2 and 3.3, there exist at least $(n-3)$ subsets of $V(T)$ whose Steiner 3-distance is 3 , and there exist at least $(n-2)$ subsets of $V(T)$ whose Steiner 3-distance is 2 . Therefore, there exist at least $(2 n-5)$ subsets of $V(G)$ whose Steiner 3-distance is at most 3. Without loss of generality, let $d_{G}\left(S_{j}\right)=3$ for $S_{j}(x+1 \leq j \leq 2 n-5)$. Then $d_{G}\left(S_{j}\right) \leq$ 5 and $d_{\bar{G}}\left(S_{j}\right)=2$ for each $\mathrm{j}\left(2 \mathrm{n}-4 \leq j \leq\binom{ n}{3}\right)$. For each $i(1 \leq i \leq x), d_{G}\left(S_{i}\right)=2$. By Lemma 3.3, there exist at least $(n-3)$ subsets of $\mathrm{V}(\overline{\mathrm{G}})$ whose Steiner 3-distance is 3 . Then there exist at most $x-(n-3)$ subsets of $\mathrm{V}(\overline{\mathrm{G}})$ whose Steiner 3-distance is 4 . If $x \leq 2 n-$ 5, then $S H_{3}(G) \geq \frac{1}{2} x+\frac{1}{3}(2 n-5-x)+\frac{1}{5}\left[\binom{n}{3}-2 n+5\right]$ and $S W_{3}(\bar{G}) \geq \frac{1}{3}(n-3)+$ $\frac{1}{4}(x-n+3)+\frac{1}{2}\left[\binom{n}{3}-x\right]$, and hence $\mathrm{SH}_{3}(G)+\mathrm{SH}_{3}(\bar{G}) \geq \frac{7}{10}\binom{n}{3}-\frac{1}{12} x+\frac{7}{20} n-\frac{11}{12} \geq$ $\frac{7}{10}\binom{n}{3}+\frac{11}{60} n-\frac{1}{2}$. If $x \geq 2 n-5$, then $\quad \mathrm{SH}_{3}(G) \geq \frac{1}{2} x+\frac{1}{5}\left[\binom{n}{3}-x\right]$ and $S H_{3}(\bar{G}) \geq$ $\frac{1}{3}(n-3)+\frac{1}{4}(x-n+3)+\frac{1}{2}\left[\binom{n}{3}-x\right]$, and hence $\mathrm{SH}_{3}(G)+S H_{3}(\bar{G}) \geq \frac{7}{10}\binom{n}{3}+\frac{1}{20} x+$ $\frac{1}{12} n-\frac{1}{4} \geq \frac{7}{10}\binom{n}{3}+\frac{11}{60} n-\frac{1}{2}$.

Case 3. $\operatorname{sdiam}_{3}(G) \leq 4$ and $\operatorname{sdiam}_{3}(\bar{G}) \leq 4$. Let $S_{1}, S_{2, \cdots,}, S_{\binom{n}{3}}$ be the 3 -subsets of $V(G)$. Without loss of generality, let $S_{1}, S_{2, \ldots,} S_{x}$ be the 3-subsets of $V(G)$ for which $G\left[S_{i}\right] \cong K_{3}$ or
$G\left[S_{i}\right] \cong P_{3}$, where $1 \leq i \leq x$. For each $i(1 \leq i \leq x), d_{G}\left(S_{i}\right)=2$. For any $S_{j}(x+1 \leq j \leq$ $\left.\binom{n}{3}\right), G\left[S_{j}\right] \cong K_{2} \cup K_{1}$ or $G\left[S_{j}\right] \cong 3 K_{1}$. Since $G$ is connected, there exists a spanning tree, say $T$. By Lemmas 3.2 and 3.3, there exist at least $(n-3)$ subsets of $V(T)$ whose Steiner 3-distance is equal to 3 , and there exist at least $(n-2)$ subsets of $V(T)$ whose Steiner 3distance is 2 . Therefore, there exist at least $(2 n-5)$ subsets of $V(G)$ whose Steiner 3distance is at most 3 . Without loss of generality, let $d_{G}\left(S_{j}\right)=3$ for $S_{j}(x+1 \leq j \leq 2 n-$ 5). Then $d_{G}\left(S_{j}\right) \leq 4$ and $d_{\bar{G}}\left(S_{j}\right)=2$ for each $j\left(2 n-4 \leq j \leq\binom{ n}{3}\right)$. For each $i(1 \leq$ $i \leq x), d_{G}\left(S_{i}\right)=2$. By Lemma 3.3, there exist at least $(n-3)$ subsets of $V(\bar{G})$ whose Steiner 3-distance in $\bar{G}$ is 3. Then there exist at most $x-(n-3)$ subsets of $V(\bar{G})$ whose Steiner 3 -distance in $\bar{G}$ is 4 . If $x \leq 2 n-5$, then $S H_{3}(G) \geq \frac{1}{2} x+\frac{1}{3}(2 n-5-x)+$ $\frac{1}{4}\left[\binom{n}{3}-2 n+5\right]$ and $S H_{3}(\bar{G}) \geq \frac{1}{3}(n-3)+\frac{1}{4}(x-n+3)+\frac{1}{2}\left[\binom{n}{3}-x\right]$. Thus

$$
\mathrm{SH}_{3}(G)+\mathrm{SH}_{3}(\bar{G}) \geq \frac{3}{4}\binom{n}{3}-\frac{1}{12} x+\frac{1}{4} n-\frac{2}{3} \geq \frac{3}{4}\binom{n}{3}+\frac{1}{12} n-\frac{3}{12} .
$$

If $x \geq 2 n-5$, then $S H_{3}(G) \geq \frac{1}{2} x+\frac{1}{4}\left[\binom{n}{3}-x\right]$ and $S H_{3}(\bar{G}) \geq \frac{1}{3}(n-3)+\frac{1}{4}(x-n+$ $3)+\frac{1}{2}\left[\binom{n}{3}-x\right]$. Thus $\mathrm{SH}_{3}(G)+S H_{3}(\bar{G}) \geq \frac{3}{4}\binom{n}{3}+\frac{1}{12} n-\frac{3}{12}$.

For $n \geq 6$, one can check that $\frac{1}{2}\binom{n-3}{3}-\sum_{i=2}^{n-1} \frac{n}{i}+\frac{7 n^{2}-23 n+20}{6} \leq \frac{3}{4}\binom{n}{3}+\frac{1}{12} n-\frac{3}{12}$ and $\frac{7}{10}\binom{n}{3}+\frac{11}{60} n-\frac{1}{2} \leq \frac{3}{4}\binom{n}{3}+\frac{1}{12} n-\frac{3}{12}$. So we only need to consider the lower bounds in Cases 1 and 2.

From the above argument, we conclude the following:

1. For $n \geq 8, \frac{1}{2}\binom{n-3}{3}-\sum_{i=2}^{n-1} \frac{n}{i}+\frac{7 n^{2}-23 n+20}{6} \leq \frac{7}{10}\binom{n}{3}+\frac{11}{60} n-\frac{1}{2}$ and $S H_{3}(G)+$ $S H_{3}(\bar{G}) \geq \frac{1}{2}\binom{n-3}{3}-\sum_{i=2}^{n-1} \frac{n}{i}+\frac{7 n^{2}-23 n+20}{6}$.
2. For $n \leq 5$, the lower bound in Case 2 does not exist. Then $\mathrm{SH}_{3}(G)+$ $S H_{3}(\bar{G}) \geq \frac{1}{2}\binom{n-3}{3}-\sum_{i=2}^{n-1} \frac{n}{i}+\frac{7 n^{2}-23 n+20}{6}$.
3. If $n=6,7, \operatorname{sdiam}_{3}(G) \neq 5$, and $\operatorname{sdiam}_{3}(\bar{G}) \neq 5$, then $\mathrm{SH}_{3}(G)+S H_{3}(\bar{G}) \geq$ $\frac{1}{2}\binom{n-3}{3}-\sum_{i=2}^{n-1} \frac{n}{i}+\frac{7 n^{2}-23 n+20}{6}$.
4. If $n=6,7$ and $\operatorname{sdia} m_{3}(G)=5$, or $n=6,7$ and $\operatorname{sdiam}_{3}(\bar{G})=5$, then

$$
\mathrm{SH}_{3}(G)+\mathrm{SH}_{3}(\bar{G}) \geq \frac{7}{10}\binom{n}{3}+\frac{11}{60} n-\frac{1}{2} .
$$

This completes the proof.
In order to demonstrate the sharpness of the above bounds, we point out the following example.

Example 3.4 Let $G \cong P_{4}$. Then $\bar{G} \cong P_{4}$. By Lemma 1.1, $\mathrm{SH}_{3}(G)=S H_{3}(\bar{G})=\frac{5}{3}$, and hence $\mathrm{SH}_{3}(G)+\mathrm{SH}_{3}(\bar{G})=\frac{10}{3}=\frac{1}{2}\binom{n-3}{3}-\sum_{i=2}^{n-1} \frac{n}{i}+\frac{7 n^{2}-23 n+20}{6}$ and $\mathrm{SH}_{3}(G) \cdot S H_{3}(\bar{G})=$ $\frac{25}{9}=\left[\frac{1}{n-1}\binom{n}{3}+\frac{(n-3)(n-2)}{2(n-1)}\right]\left[\frac{1}{2}\binom{n}{3}-\frac{(n-3)(n-2)}{2(n-1)}\right]$, which implies that the upper and lower bounds are sharp.
